2. Any one time, non-exclusive use of photographs or AV material for publication, exhibition, or any and all other purposes requires written permission from this department. Any commercial use requires a completed **Application for Permission to Publish**.
3. Materials used for exhibition or publication must be credited to the Special Collections Department, J. Willard Marriott Library, University of Utah.
4. The publishing party will supply the J. Willard Marriott Library, Multimedia Division with two copies of the book, periodical, film, or any other work in which and item is exhibited.
5. The Library does not claim to control the copyright for all the materials in the collection. The publishing/production party assumes all responsibility for clearing reproduction rights and for any infringement of United States copyright law. The library has no readily available information concerning the existence and/or whereabouts of copyright holders.
6. The Library reserves the right to refuse permission for the use or reproduction of materials when such restrictions have been specified by a donor.
7. The Library hereby notifies patrons that rush order service may not be possible, given the nature of the original item, the time of the request, and other conditions beyond the Library's control. The Library assumes no responsibility for missed deadlines in case a rush service is not available.
